### 1. REVIEW OF MEETING PROTOCOL AND AGENDA

DISCUSSION Meeting Protocol and Agenda Review. Chuck Roy, President

#### 2. DETERMINATION OF QUORUM

DISCUSSION Quorum determination by Chuck Roy, President
 Quorum was determined. Mr. Roy reported that minimum of 1 presiding officer and 15 voting members is needed to be present to obtain quorum and those requirements were determined to be met for this meeting

#### 3. MEETING MINUTES

**DISCUSSION** Approval of meeting minutes from August 19, 2023, meeting by Chuck Roy, President

• Meeting Minutes were provided for review from the last all BALA Membership Meeting held, 8/19/23. Upon a motion properly made and seconded, a vote was held, and the minutes were unanimously approved

#### 4. TREASURY REPORT

DISCUSSION Treasury Report and Approve Financials by Deb Gran, Treasurer

- Ms. Gran presented P&L and balance sheet for 2023. Income was just under \$40,000 included dues of \$15,000, BALA Gala auction income of \$7,500, and Friends of the Lake donations of \$9,600 (all approximate). Expenses were just under \$34,000 and included work on an Order of Conditions from the Conservation Committee and the hiring of Lake Manager. Thus, there was a surplus in 2023 of \$6,618.
- For the period from January 1, 2024 through July 8, 2024, dues so far are \$14,500 and Friends of the Lake donations were very high at \$18,600. BALAGala has yet to be held. Expenses so far totaled just over \$37,000 and included approximately \$33,000 for weed treatment. The current cash balance is just over \$50,000.
- After further discussion, and upon a motion duly made and seconded, the financials were approved.
- Ms. Gran noted that the budget approval would be handled in new business.

#### 5. MEMBERSHIP COMMITTEE

DISCUSSION Update Report by Barbara Hitchcock, Committee Chair

- Ms. Hitchcock noted that the current membership tally was up to approximately 97% of expected qualified residents, which was a very high number.
- She then gave a summary of her activities including her membership mailings, calls, and follow up.

#### 6. RECREATION COMMITTEE

DISCUSSION Update Report by Mari Roy

Ms. Deterando, Chairman, was absent, and Ms. Mari Roy gave the report in her absence. She noted the following 2024 events: (1) Welcome to the Season (and new residents) was held in May at Rapscallion with 70 people attending, (2) a boat tie up was held on July 18<sup>th</sup> with four boats, (3) BALA Gala will be held on August 2, and (4) the next boat tie up is scheduled for Aug 9<sup>th</sup>. The Welcome Event will be held next year in May.

#### 7. DAM AND FISHING COMMITTEE

**DISCUSSION** Update Report on Dam and Fishing on Big Alum by Ken Gajewski, Committee Chair

It was reported that the lake level is at normal levels, and that dam will be closed on Nov 1<sup>,</sup> 2023, for a drawdown of 30 inches. The draw down in 2025 will be 36 inches.

#### 8. ENVIRONMENTAL COMMITTEE/SLAC COMMITTEE/SLAC

**DISCUSSION** Environmental status of Lake Report by Bruce Gran, Committee Chair

- Mr. Gran noted that Ponds & Lakes has started the new treatment regimen with the application of SONAR. He noted that generally there are two types of weeds in Big Alum: (1) clasping leaf, a native plant that grows fast and is easy to pull out in your swimming area (lay out to dry and then throw away) and (2) curly leaf, an invasive species that is in just a few locations mostly down by the boat ramp.
- Mr. Gran noted that the clarity of Big Alum is very good.

#### 9. WATERSHED/LAKE DRAINAGE PROTECTION COMMITTEE

**DISCUSSION** Watershed/Lake Protection Issues Report by Tom Clarke, Committee Chair

Mr. Clarke started by noting that the water in Big Alum comes from springs and runoff and his focus is to
ensure the runoff is as clean as possible and not silty. He mentioned three areas he is focusing on: (1) Mt.
Dan Rd – the Mt Dan Rd Association hired a contractor to regrade and pitch the unpaved road, add retention
ponds, and clean all sump basins and ponds. He noted that the contractor did a great job and that no silt is
flowing into the lake. (2) Paradise Rd – there was some silting issues with a house under construction across
the road (not on the lake) but that the contractor has fixed the issues. (3) North End – there is a retention
pond that is not working to contain the flow down from Old Towne Rd and he is working with the town and
landowners to remedy.
